About Us

Who we are

Side By Side Advocacy is an independent, community-based advocacy organisation that promotes and upholds the rights, needs and interests of people with intellectual disability to enable full and meaningful participation in the community.

Our Vision

We envisage a world where people with disability are equal and valued; where diversity is celebrated, needs are fulfilled and opportunities realised.

Advocacy is

Speaking, acting and or writing with a minimum conflict of interest on behalf of the sincerely perceived interest of a person with disability in order to promote, protect and defend their interests, rights and needs. Advocacy strives to be independent, empathic and vigorous and can be costly to advocates.

At Side By Side Advocacy, advocates are side by side with someone when they are facing challenging situations, navigating complex systems, dealing with uncertainty, or being treated unfairly.

The definition of advocacy has been adapted from the original definition of Wolf Wolfensberger (1992), in his 1992 presentation titled Social Advocacies on behalf of devalued and disadvantaged people.

Our purpose

Side By Side Advocacy promotes and upholds the rights, needs and interests of people with disability to enable full and meaningful participation in the community.

We recognise that people with intellectual disability experience particular barriers in having their voices heard and needs met and for that reason we specialise in providing advocacy for people with intellectual disability.

Our Way of Working

We seek to maximise opportunities for people with disability to take control of their lives and live a good life as contributing members of their community. Chairperson's Report

2022 – 23 has been a busy and challenging year for the Board of Management of Side By Side Advocacy. All members of the Board are volunteers – the goodwill, time and dedication of each member has made a positive impact on the efficacy of the Board. I would like to thank all members for the expertise, life experience and dedication that they have brought to their roles this year.

In particular, I would like to acknowledge the dedication of Ruth Perram. Ruth joined the Board in 2013 and has served as secretary since 2014. Ruth contributed countless hundreds of hours attending to the often unrecognised but vital compliance tasks of the Board. Ruth has decided that it is time to pass the baton onto someone else. Ruth's generosity and attention to detail will be hard to match - although we are very fortunate to have identified a new member to take on the role of Secretary going forward. We will not lose Ruth's wisdom or knowledge as she will be continuing as an ordinary member. This expected change will occur after 2023 Annual General Meeting.

Every now and then something crops up that is not predictable requiring everyone in the association to dig deep, think outside the square and pull out all stops to ensure that challenges put before us are be treated as opportunities, rather than problems. Each February the Board holds a planning day. One of the issues identified during our risk management evaluation was the growing inadequacy of the premises in West Ryde.

While there were many positive attributes to current office space (15 year connection to community, access to transport and parking, pleasant setting in keeping with Social Role Valorisation values, affordable rental... to name a few)

the lack of space and absence of private offices to have confidential conversations and interviews was identified as a potential risk to the effective delivery of our advocacy. We undertook to keep a lookout for suitable premises that ticked all the boxes, while still being affordable.

Be careful what you wish for!

In April we were given notice by our landlords that we needed to vacate the premises. And so the hunt was on, now with urgency, for suitable yet affordable premises. It soon became clear that our wish list was not attainable on our budget. We could see this a problem or an opportunity – and with the positive attitude of the Executive Officer and staff the choice was easy. A suitable and affordable office was located in Parramatta.

Although moving outside Ryde Local Government Area for the first time in 30 years was a difficult call, it also meant an opportunity to develop and strengthen relationships in an area in which we already provided advocacy. Through an enormous amount of effort, cooperation and sheer hard work, the move took place seamlessly, with no downtime for clients and program participants. My heartfelt thanks everyone who made this happen so efficiently, and for the positivity that transformed a challenge into an opportunity.

While saying goodbye to Ryde was difficult, it was not our only significant farewell this year. After ten years in the role as Citizen Advocacy Coordinator, Deb Maio decided that it was time for her to retire, and her last day will be on 4 July 2023. Deb made a wonderful contribution to the Citizen Advocacy Program during her tenure matching, supporting and establishing citizen advocacy relationships. Deb's passion and enthusiasm were outstanding, as was her contribution to the organisation as a whole. We wish Deb all the best in her future ventures.

One of the participants in the Citizen Advocacy program passed away this year. Sarah had been part of the Citizen Advocacy program since 1997. Many of us knew Sarah well as she was a regular at the Side By Side Advocacy cocktail parties and other events of the association. Sarah will be missed and fondly remembered. Our condolences to her friends, family, work colleagues and Lisa, her citizen advocate.



Updating the constitution of Side By Side Advocacy is a project that the Board has been working on for the past two years, and this is certainly not a task that we considered to be a usual function of our day to day activities. Such a project involved copious amounts of reading, researching, drafting and redrafting. We undertook much consultation along the way with stakeholders and experts from inside and outside the organisation. We believe that the version being presented to the membership at the Annual General Meeting in 2023 is compliant with all relevant legislation and supports the organisation into the future as we strive to model inclusive practises and provide a leadership in advocacy provision. Thank you to everyone who was involved in this major undertaking.

It is heartening indeed to see that our membership has grown over the past year. Some of these members have expressed an interest in joining our Board. This undoubtedly reflects the significant effort that has gone into promoting our association in the community. Our promotional materials, the new role of Communications and Information Officer, and the 30th Anniversary Citizen Advocacy celebration were just some of the ways that Side By Side Advocacy engaged with the wider community this year, with the aim of increasing awareness and understanding of our work. Our new, accessible website will continue to build on this work.

Through outreach associated with our role in supporting people considering making a submission to the Disability Royal Commission and through our many workshops and co-design activities, Side By Side Advocacy has grown in status and reputation – even taking out a Highly Commended Award at the Northern Districts Small Business Awards in November 2022.



I would like to commend and thank the staff for their skill, dedication, and tenacity again this year. The team, so ably led by Kim Roots, is a cohesive and collative group of professionals. They have shown flexibly, resilience, good humour, and good grace throughout the year. The staff do an amazing job and continue to make a difference, every day in the lives of people with disability. Executive Officer's Report

2022 – 2023 has been a year of both change and of continuity.

One thing that has continued is high demand for advocacy. Side By Side Advocacy's reputation as a specialist advocacy provider for people with intellectual disability continues to grow. This has resulted in more referrals and more people with disability seeking advocacy.

We continued to demonstrate our commitment to proactive advocacy as we celebrated more than 30+ years of Citizen Advocacy at Side By Side Advocacy.

We hosted an event that brought together colleagues, friends and allies who have played a part in the Side By Side Advocacy journey over those many years.

We also created a video about Citizen Advocacy to help people understand the way the program works and encourage local citizens to get involved.

It has been a year where there has been particular scrutiny of the life experiences of people with disability and the barriers to inclusion. Significantly, the Disability Royal Commission invited people with disability and their allies to share their experiences of abuse, neglect and exploitation and their suggestions for change. Side By Side Advocacy shared specialist expertise and insights to inform these enquiries. We supported people to make submissions and made a submission based on our experience. We also participated in consultations and contributed to papers.



We have acted locally, including participating in the City of Ryde Council Access and Inclusion Committee. We also acted nationally via our systemic advocacy and contributions to the work of the Disability Advocacy Network Australia (DANA).

As an organisation we continue to model inclusive practices. Our Inclusive Governance team has been sharing research findings about meaningfully including people with intellectual disability in organizational decision making – including on management committees and Boards. We have continued to develop a suite of plain English and Easy Read resources. We have new, accessible business cards. We use accessible fonts in our communications. We have a new website with accessibility features that is due to be launched soon.

There have also been big changes.

We increased the geographical area we provide individual advocacy (IA) to include Parramatta and surrounds. We have also expanded the areas we provide advocacy across the Hills and Ku-ring-gai. This allows us to provide advocacy to a greater number of people with disability. In a significant change, we moved offices in June. We left West Ryde after 15 years at Herbert Street – and after more than 30 years in the local area. Our new office in Parramatta offers more space and is well located for a range of public transport.



We have also created and hosted new events. 'My life, my way' was one event co-designed and co-presented by people with intellectual disability. More events are planned. We hope these events will offer opportunities for skill development and peer networking.

I want to extend my appreciation to everyone who has contributed their time, skills, life experiences and commitment to the change making work of the organisation. This includes the fabulous Board, staff, co-designers, presenters, workshop attendees and sector allies.

In this time of sector change, the team at Side By Side Advocacy is looking forward to continuing our work to promote the rights, needs and interests of people with disability.

Systemic Advocacy


Our systemic advocacy has involved multiple strategies.

- We made submissions to the Disability Royal Commission including about the importance specialist advocacy for people with intellectual disability and the preliminary findings of our research about inclusive governance.
- We contributed to a consultation by the Bureau of Crime Statistics and Research into support needs of people with complex support needs who engage with the criminal justice system in NSW.
- We shared insights with the NSW Department of Education about the impacts of Covid19 on students with disability.
- We provided feedback on the Intellectual Disability Health Capability Framework to the Department of Health and Aged Care.
- We are members of the Citizen Advocacy Trust Advisory Committee.
- Staff participated as Citizen Advocacy Program Evaluation (CAPE) team members of a Queensland Citizen Advocacy Program.
- We shared insights at the Quality and Safeguards Commission Advocacy Forum in Melbourne.
- We provided input to Zero Barriers about the inclusion of people with intellectual disability in community settings.
- We are members of the City of Ryde Inclusion and Access Working Group and provide insights about including people with disability.
- The Executive Officer is a Director of Disability Advocacy Network Australia (DANA) and attends meetings relating to sector issues.
- We are members of the NSW Disability Advocacy Network and contribute our insights to the systemic efforts of the network.
- We contributed to Disability Advocacy Network Australia's submission relating to Administrative Review Reform.
- We made an oral and written submission to the National Disability Insurance Scheme Independent Expert Review.

Citizen Advocacy

Citizen Advocacy promotes and protects the rights, needs and interests of people with intellectual disability. It does this by connecting a person with intellectual disability who has unmet needs with a citizen who is interested in having a long-term connection with that person

Side By Side Advocacy started with a Citizen Advocacy Program and in 2022 we celebrated 30+ years of Citizen Advocacy.

The Citizen Advocacy Program began because of a recognition of the unmet needs of people with intellectual disability living in the Ryde and Hunter's Hill areas.

Unlike other forms of advocacy, citizen advocacy is proactive, ongoing and is provided by a person who is unpaid.

For people with intellectual disability with few, if any, freely given relationships, having someone to do fun things with, to act as a sounding board and to help them to speak up about issues can be life changing.

Citizen advocates spoke up about a range of issues including:

- critical equipment that did not work
- the opportunity to do fun things rather than just stay at home
- significant health needs
- the opportunity to have a job
- people with disability experiencing neglect.

"I see it as a long term commitment. I always feel good after we meet.

Reflections from a citizen advocate

There were also many birthday celebrations, catch-ups over coffee and reunions of long lost friends.

One highlight was the gathering to celebrate more than 30 years of Citizen Advocacy at Side By Side Advocacy.




The event brought together people who have made a fabulous contribution to the organisation over many years. There were people with disability, citizen advocates, former board members and a whole range of highly valued stakeholders.

We appreciated that colleagues from other advocacy organisations and community groups attended to help us celebrate. The event was possible due to funding from City of Ryde Council.



Another highlight was the creation of a video to promote Citizen Advocacy. A big thanks to Max, David, Chris, Jeannette and Angela who participated in the video.



A coming change is the departure of our fabulous and highly respected Citizen Advocacy Coordinator, Deb Maio. In July 2023, Deb will be retiring after 10 years at Side By Side Advocacy - and many years before that in the disability sector. Her contribution has been enormous and she will be missed.

Individual Advocacy

Individual Advocacy is one-to-one advocacy support for people with disability when they are in difficult situations or being treated unfairly. Side By Side Advocacy specializes in providing advocacy for people with intellectual disability.

2022 – 2023 has been a very busy year for the Individual Advocacy team. We have provided advocacy support in the way that best suits the needs of the person seeking advocacy.

This included supporting people to self-advocate where possible. Sometimes, people seeking advocacy have limited capacity to self-advocate due to their personal circumstances or support needs. Where self-advocacy was not possible, we worked alongside friends, allies and family members of people with disability, where appropriate. We also spoke up on behalf of people with disability.

Advocacy included:

- Speaking up for people with disability to have safe, appropriate, accommodation
- Securing essential repairs in rental accommodation
- Ensuring children with disability to have the support they need at school
- Supporting people to get critical medical treatments
- Assisting people with disability to get the support they need to be included in their community
- Escalating complaints about poor service provider conduct
- Supporting people to access savings via the NSW Trustee and Guardian.

Assistance to make decisions is frequently an important aspect of advocacy support. This need arises for a range of reasons. For some people, it is due to

their age or the nature of their disability. Many people seeking advocacy have experienced barriers to community engagement and may have had limited life experiences. For this cohort, advocacy may include the chance to try out new things that are conceptually unfamiliar. It sometimes includes drawing images or showing photographs. It often includes multiple advocacy sessions to allow time to consider options.

Our trauma informed approach includes advocates meeting with people in a location that suits them.

It could be our office, their home, a local café or other public space such as a library.

Throughout the year, we also introduced people seeking advocacy support to other professionals such as legal services, as appropriate. On occasion, we worked alongside these professionals to provide communication support.

"...you have helped me so much, you always listen to me....and understand me."

"Thank you for giving me a solution. You turned the problem around and saw something I didn't see." Individual Advocacy is available to people with disability in most locations in the Northern Region of Greater Sydney and in Parramatta and Cumberland Local Government Areas.





"Your help is life changing and you're there for me whenever I need you.... You were the one who held my hand, went through the darkest days of my life! I feel great after opening up, thanks for the opportunity".

National Disability Insurance Scheme – Appeals Support

Appeals Support assists people with disability who want to have a review of a decision made by the National Disability Insurance Agency in the Administrative Appeals Tribunal (AAT).

This support can be: explaining the review process, including what is involved in appealing to the AAT; helping to prepare documents; and providing advice and skills so appellants can better represent themselves

NDIS Appeals Support is available for people with disability in Greater Sydney.

Features of the year are noted below.

- High demand for National Disability Insurance Scheme (NDIS) appeals advocacy with requests throughout the year far outnumbering available supports.
- Advocacy organisations providing NDIS Appeals support across the state, were at capacity and largely not taking on any new clients making it challenging to make referrals.
- Wait-times for one-off advice sessions at Legal Aid and the Administrative Appeals Tribunal were also long, with people with disability often waiting months for a one hour advice session.
- In addition to these challenges, it was announced that the Administrative Appeals Tribunal would be shutting down. This caused considerable confusion as no clear information was available beyond stating that all cases would be heard.

In response to these challenging set of circumstances, Side By Side Advocacy offered information and guidance sessions for anyone seeking appeals support advocacy. Providing one to one information sessions was a highly successful strategy in meeting advocacy need in the community and supporting individuals to self-advocate at the tribunal in lieu of on-going advocacy support.

Side By Side Advocacy has received excellent feedback with people reporting that the session empowered them to:

- engage in tribunal processes / procedures
- negotiate with agency representation
- prepare documents for appeal
- apply for legal services.

We were frequently told that without the advice session, the person with disability would have made serious mistakes during hearings such as missed time-limits or failed to comply with directions.

Ongoing advocacy support has also been provided for people with disability who would have found it challenging to self-advocate or to access advocacy from a non-specialist organisation.

Advocates have also engaged in advocacy aimed at improving systems relating to appeals. For example, Side By Side Advocacy was invited to provide a submission to the NDIA Independent Expert Review Program Evaluation.

Information has also been shared with other organisations to enhance the capacity of others in the sector.

"I would have been completely lost at the AAT without the oneoff advice that Tina provided."

"Tina is the reason we finally got the support for my son."

Jane (not her real name) is an example of a person with disability who received advocacy support to appeal a decision of the AAT.

Jane needed help to access the NDIS. The nature of her support needs made it unsafe for Jane to engage in self-care and daily living activities. On one occasion she experienced serious injuries while cleaning. She was seeking help with daily living tasks from the hospital. And yet, Jane had very low prospects of success according to the Legal Aid referral.

Jane had been trying to gain access to the NDIS for several years and had recently turned 65. People over 65 are not eligible to access the NDIS so this was her final opportunity. This made Jane's circumstances more urgent.

Some ways the advocate worked with Jane were to:

- obtain evidence of her needs including from the hospital that had been helping with daily living tasks
- negotiating for the NDIS to pay for an independent assessment so that an Occupational Therapist could verify risks to Jane's safety
- assist Jane to explain her situation including at the AAT.

Jane obtained the support she needs. Jane was deeply grateful for the advocacy of Side By Side Advocacy.

Disability Royal Commission Advocacy

The Disability Royal Commission looked into how to:

• stop people with disability experiencing violence, abuse, neglect and exploitation

• be better at reporting, investigating and responding when people with disability experience violence, abuse, neglect and exploitation

• work towards a more inclusive society.

Throughout the Disability Royal Commission, Side By Side Advocacy engaged with people characterised by the Disability Royal Commission as being from 'hard to reach communities'. This included people living and working in disability specific contexts such as semi-devolved institutions and Australian Disability Enterprises.

One person summarised their experience of devaluation eloquently as follows:

'...my time isn't worth anything, but if I keep them awaiting, I get in trouble.'

We embraced trauma informed practices. We listened to the needs of the cohort we engaged with. We worked at the pace desired by the person considering their submission.

Key learnings were:

- Trust takes time to earn same time, same place, same people
- Relationships are indispensable
- The seemingly trivial can be the most consequential
- Moving beyond purely reactive advocacy allows for lasting change
- Advocacy that meets people where they are at literally and metaphorically – works.

Embracing and acting on these learnings allowed people with significant cognitive and/or communication support needs the time and space to move from the 'trivial' to the sophisticated articulation of their experiences, values and aspirations.

For some people, nurturing an ongoing advocacy relationship resulted in meaningful life outcomes that would not otherwise have been possible.

Some outcomes were:

- For one person, premature entry to a residential aged care facility was averted.

- For one person, it was the sense of having left the abuse behind that allowed them the chance to begin catching up on the life that had been taken from them.
- For one person, it was the opportunity to build a support network of their own choosing that allowed them to flourish.
- For another, it was being able to teach peers about their rights and what it means to have valued status.
- For a few people, it meant choosing where they lived for the first time in their life.
- For many people, it was re-establishing connections which had been severed by the actions of others.

Side By Side Advocate, Cathy Milne, gave evidence at Public Hearing 32 in Brisbane. She was one of four advocates selected by Kate Eastman AM SC, Counsel Assisting the Royal Commission. Cathy's invitation was issued following advocacy support to Public Hearing witness 'Charlotte' who gave evidence at the public hearing on Homelessness, and the work done to support 'Charlotte' build skills and supports to move on from abuse and violence. After giving evidence and moving on from the experiences of abuse: "I just want to live a life."

As the Royal Commission wound down, Side By Side Advocacy embraced additional strategies including hosting workshops for people with disability. The content of these workshops was informed by the information and ideas people with disability told us they needed throughout the Royal Commission. One workshop was called 'My life, my way'. It was co-designed and copresented by people with intellectual disability. The workshop was described by one participant as 'life changing.'



The Disability Royal Commission has now come to an end. The final report is expected in October 2023.

Inclusive Governance Project

Inclusive governance is about people from many backgrounds and life experiences being involved in the management and decision making of organisations.

Side By Side Advocacy is researching the experience of inclusion of people with intellectual disability on management committees and boards.





Inclusive Governance Research Team – Dr Bernadette Curryer, Inclusive Governance Project Officer Will Harding, Co-researcher Katrina Sneath, Co-researcher

The Inclusive Governance Project has continued to explore the experience of Board membership by people with intellectual disability. We are using what we have learnt to guide the development of resources to enable organisations to implement increased inclusion at a governance level. An extension of funding from the Australian Government's Department of Social Services (DSS) was received, allowing the project to continue after the original end of February 2023, until mid-2024.

The research component of the project has now been completed with a total of 27 participants being interviewed. (5 Board members with intellectual disability, 5 Board members with a physical/sensory disability, 4 Board members without reported disability, 8 Executive Officers or other staff members, 4 Board support people and 1 Board Observer). These participants talked about their experience in 21 community organisations.

5 themes emerged from the interviews. These themes reported the impact of inclusive governance, pathways to Board membership, experiences that effect Board inclusion, support received and concerns that became barriers. The findings of the research informed the development of 5 Principles of Inclusive Governance:

- 1. Inclusion of people with intellectual disability in the decisionmaking and governance of community organisations is valued.
- 2. There are clear pathways to Board membership for people with intellectual disability.
- 3. Board meetings and activities are accessible, meeting the inclusion needs of people with intellectual disability.
- 4. Individualised, skilled support is provided.
- 5. There is a commitment to making Inclusive Governance work.

There were a number of activities undertaken that supported the project, to complete the research, create resources, and disseminate findings. People with lived experience were involved whenever possible.

It's a matter of moral coherence to have people involved in every level of the organisation who have lived experience. It deepens the whole endeavour [P11_E].

Board of Management

Chairperson – Coralie Jensen

Coralie has a professional background in education and management. She is passionate about social justice and inclusion for all people who are marginalised. As the mother and carer of a person with disability, Coralie has lived experience of disability and knowledge, experience and training in advocacy. After eleven years as a volunteer of Side By Side Advocacy, Coralie joined the Committee of Management in 2003, and has served in the position of Chairperson since 2007. Coralie has contributed to the organisation in many other ways including event management, policy writing, public speaking and lobbying for the organisation around funding and disability issues in general. Coralie continues her dedication to the work of Side By Side Advocacy as a memorial to her son Finley who passed away in 2012.

Vice Chairperson – Michelle Donelly

1. **Corporate Information**

Side By Side Advocacy Incorporated operates under the Association Incorporation Act 2009 (NSW). Its business premises are located in Parramatta & operates across Greater Sydney.

Summary of Significant Accounting Policies 2.

Basis of Preparation a)

This general purpose financial report has been prepared in accordance with Associations Incorporation Act 2009 (NSW), Australian Accounting Standards and other authoritative pronouncements of the AASB & Urgent issues group interpretations. The financial report has been prepared on the basis of historical cost and does not take into consideration changing values of money or current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

Significant accounting judgments, estimates & assumptions b)

The preparation of financial statements requires management to make judgements, estimates & assumptions that affect the application of policies and reported amounts of assets, liabilities, income & expenses. The estimates and associated assumptions are based on historical experience and other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making judgments. Actual results may differ from these estimates

The estimates & underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods if the revision affects both current & future periods.

Revenue Recognition C)

Revenue is recognised when the association is legally entitled to the income and the amount can be quantified with reasonable accuracy and is net of GST

d) Expenditure

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category

e) Cash

Cash & Cash equivalents in the balance sheet comprise cash at bank and in hand and in short term deposits are stated at their nominal value

f) **Trade Debtors**

Trade Debtors are stated at original invoice amount less any Provision for doubtful debts where applicable. Normal trading terms are 7 to 30 days

Plant & Equipment g)

Fixed assets are depreciated over the expected useful life on a prime cost basis.

Grants in Advance h)

Grants in Advance are carried forward at their original amount and are to be provided subsequent to the balance date

Employee Leave

The liability for Annual & Long Service Leave is recognised and measured at the amount expected to be paid when liabilities are settled

Provisions j)

These are recognised when there is a present obligation as a result of past funding and it is probable that an outflow will be required using reasonable estimates

k) **Government Grants**

Grants are matched against expenditure in the year expenditure is incurred and in accordance with funding body requirements
